Min PM74/25 - Planning applications received for consideration

- 1) **PA25/03668.** Application for Permission in Principle for the construction of up to 1no bungalow (minimum of 1, maximum of 1). Location: 61 Phernysick Road, St Austell, Cornwall, PL25 3TU

It was **RESOLVED** to **SUPPORT** the application. Proposed: Cllr P Highland, Seconded: Cllr J Eyre. All in Favour.

- 2) **PA25/03776.** Outline application for residential development of land for up to 1no dwelling including access. Location: 3 Treverbyn Cottages, Treverbyn Road, Stenalees, St Austell, Cornwall, PL26 8TL

It was **RESOLVED** to **SUPPORT** the application. Proposed: Cllr Mrs. A Double, Seconded: Cllr M Luke. All in Favour

Min PM75/25 - Planning Decisions

- **PA25/02273** – Retrospective change of use from garage with hobbies room/store above to standalone dwelling. Location: Eglosmere, Trethurgy, St Austell, Cornwall. PL26 8YF. The Parish Council supported this application on 29.04.25. Cornwall Council Planning Department have subsequently **APPROVED** the application.
- **PA25/00341/PREAPP** – Pre-application advice for proposed erection of 6 (No.) residential dwellings. Location: Land North of Windwhistle, Trethurgy, St Austell, Cornwall. The Parish Council were not consulted on this pre-application. Cornwall Council Planning Department have since closed the application, with advice given.

Min PM76/25 - Planning Correspondence

5-day Protocol

Following already circulated documentation to Committee Members, The Clerk tabled a 5-day protocol notification, regarding **PA24/06769** – Erection of Showroom, and ancillary offices on land north-east of 3 Bojea Industrial Estate (Global House), Bodmin Road, Trethewel.

The Parish Council objected to this application on 10.12.2024. The Planning Officer is recommending the granting of planning permission.

The Clerk read the Planning Officer's comments, as well as relay the thought of the Chairman of Planning, Cllr L Allen in his absence.

After much debate and discussion, it was proposed by Cllr P Highland, seconded by Cllr J Eyre to 'Agree' with the Planning Officer in now supporting the application.

Four in Favour, with one against (Cllr M Luke) and one abstention (Cllr B Hollis).
