

**Treverbyn Parish Council – Monthly Report**  
**Cllr Jamie Hanlon**  
**Reporting Period: July 2025**

**1. Community Engagement and Environmental Improvements**

- **Treverbyn Estate Site Visit:** Conducted a comprehensive walkaround with Cormac to address concerns raised by residents in Hallane Road and Trenarren View, including overgrown hedges, lack of drop kerbs, and inconsistent grass cutting. These issues are historical and have been raised by residents. Followed up on the installation of dog fouling signage and requested a coordinated intervention plan.
- **Bin Location:** Treverbyn Parish Council is looking for a location to site one of their allocated bins, either at the entrance to Hallane Road or Trenarren View.
- **Community Day Planning:** Supported the proposal for a community-led event to improve estate upkeep and volunteered to identify local participants. I hope to lead this with Cormac in August.

**2. Council and Committee Work**

- **Health and Adult Social Care Overview and Scrutiny Committee (HASCOSC):** Participated in discussions on the temporary closure of Launceston MIU and broader NHS staffing challenges. Contributed to shaping the committee's work programme, including scrutiny of NHS dentistry and winter pressures.

**3. Infrastructure and Accessibility**

- **A30 to St Austell Link Road:** Raised accessibility concerns regarding event venues and reminded organisers of their obligations under the Equality Act 2010. Coordinated with Highways on signage and traffic control measures affecting the A391. We have been informed that the full opening and signage won't be until the end of July. I have raised concerns about the new path being built along the A391 Link Road, which is only 3 metres wide and is supposed to be for pedestrians, cyclists, and horses. Additionally, some sections of the new link road lack curbs or barriers, providing no protection for path users in the event of an incident.

**4. Planning and Development**

- Responded to a resident's query about a proposed housing development in Trethurgy, clarifying planning history and directing them to appropriate complaint channels.

**5. Equality and Inclusion**

- Advocated for the provision of hearing loops at meetings and events in County Hall and external events. Requested a cross-departmental meeting to address repeated accessibility issues and ensure compliance with the Equality Act. Requested under The Freedom of Information (FOI) Disability Access Audits, Access Statements for all

buildings owned by Cornwall Council and all external spaces owned by them. Also requested service and maintenance reports for all hearing loops and their locations.

## 6. Local Projects and Funding

- **Whitemoor Village Hall – Community Capacity Fund:** Reviewed and supported the COM001-T-150 funding application, highlighting its potential to improve accessibility and community infrastructure.

## 7. Shadow Cabinet Member for Adult Social Care and Health Partnerships

- As the Reform Shadow Cabinet member, I have my first meeting on Wednesday, 30th July 2025.
