# Min PROW14/25 - Minutes of the Public Rights of Way Meeting held on the 16<sup>th</sup> September 2025

The minutes of the said meeting had been published and circulated to all Committee Members in advance of the meeting. They were duly accepted as a true and accurate record.

# Min PROW15/25 – Any Footpath, Bridleway and Byway Maintenance to note/report

It was reported that the A391 path needs clearing following the new footway works that have been carried out.

It was **RESOLVED** that the Clerk write a letter to Cornwall Highways.

Proposed: Cllr G Tregidga, Seconded: Cllr M Luke. All in Favour.

Footpath 424/29 was discussed and it was agreed that the Kerrow Moor end, be looked into for accessibility and vegetation overgrowth.

Various footpaths at the top of Trenance Downs were discussed.

It was suggested that when a comprehensive list of footpaths in the Parish is collated, that a 'suitability' column be added with particular assistance for those members of the public with access needs.

### Min PROW16/25 - Enhanced LMP Scheme Application

Roger Fleet attended the meeting with a newly created database of Parish Footpaths. The Chairman expressed his gratitude for Roger's sterling work. This valuable information would be incorporated into the materials the Administrator had already compiled on the Parish's Gold footpaths.

As agreed at the previous meeting, it was emphasised that any ongoing work should focus specifically on the approximately 11 Gold-classified footpaths in the Parish. This focus will help in preparing a submission regarding signage to be included in the ELMP application.

It was suggested that all 11 (approx.) footpaths were walked over, and any findings reported back. Members then agreed what footpaths were to be walked over. Of importance, it was stressed that the prioritised gold footpaths were in need of being walked, as a matter of urgency.

A newly created Messenger group would be established, in order to report back, and to upload any photos. **Action: Chairman, Cllr B Hollis**.

In future, the NAS box system would be able to be used for such a database.

### Min PROW17/25 - Any Other Business

Cllr L Allen commented on the proposed Clay Trail closure coming up in Ruddlemoor. The Clerk provided further feedback to all members.

It was agreed to revisit the closure of 424/4. **Action: The Clerk to communicate** with previous stakeholders with whom he was liaising with.

The Clerk provided an update on the broken footbridge at Molinnis Moor.

The Clerk provided confirmation, that the letter of support to promote the
reopening of the Trenance to Menacuddle Well path, has now been submitted.
