### **Min PROW01/26 – Apologies:**

### **Min PROW03/26 - Public Participation:**

### **Min PROW04/26 - Minutes of the Public Rights of Way Meeting held on the 18th November 2025**

### **Min PROW05/26– Any Footpath, Bridleway and Byway Maintenance to note/report**

It was reported that a tree is down on the Bojea footpath (424/1).

Stannary Rd to Treverbyn Road Footpath – Condition of the path is in need of being assessed. **Clerk to action**

Mr R Fleet reported that there is a tree leaning on the power line along the B3274 on Bodmin Road nearly opposite Menacuddle Well. **ACTION:** Clerk to report to Western Power.

### **Min PROW06/26 – Enhanced LMP Scheme Application**

Cllr B. Hollis is working through the new spreadsheet of Parish footpaths, combining what the Administrator has produced, with the work Mr R Fleet has undertaken.

Cllr B. Hollis then presented his work so far, to all members. It was agreed that a sterling job had been carried out.

It was **RESOLVED** to apply for new signage for the gold footpaths in the Parish and Cllr B. Hollis and the Clerk to look at exact numbers and email the committee.

### **Min PROW07/26 – Communication and Access Methods for Member Inputs to the Master Spreadsheet**

Members discussed the best way to access and update information on the footpaths. It was **RESOLVED** to go ahead and use Google Docs.

Proposed by Cllr M Shand, Seconded: Cllr M Luke. All in Favour.

### **Min PROW08/26 – Any other Business**

Cllr M Luke suggested a meeting with Roger Gates, Community Link Officer to discuss information boards, signs and where they could be placed on the Clay Trails. Public video footage of the pathways could also be shared.

The intended Ruddlemoor clay trail closure was discussed, and the Clerk/Cllr B Hollis relayed findings of their walkover of the proposed alternative route to all members.

The Clerk relayed to members that he has reported the condition of the footpath, from the Lower Molinnis Play area, to Molinnis Moor.

The Clerk will send around the ELMP information to all members.

It was also discussed that Charlie from Habitat come along to a future meeting to discuss thoughts on the footpaths as the contract is held by the company.
